It is with great sadness that we inform you Mark Pierce, Superintendent, Tiffany Greens Golf Club, lost his battle with cancer on Saturday, May 10, 2014. Mark was a long time member of the Heart of America GCSA chapter, an advocate for his profession; along with being a great mentor and friend to many in the Kansas City area.

Mark Pierce - age 55, was born June 24, 1958, the son of Robert Gene and Florence Ruth (Russell) Pierce in Kansas City, Kansas, and passed away with his family at his side May 10, 2014 in Platte City. Mark is preceded in death by his father. Survivors include his wife, Kay of the home; mother, Florence, Kansas City, KS; three children, Terra Pierce, Excelsior Springs, Josh Pierce (Terri Anne), Leavenworth, KS; and Austin Brady, Cottonwood, CA; one brother, Robert Pierce (Melinda), Smithville; and granddaughter, Lexi O'Dell.
